- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/ Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.

3. AND WHEREAS, the ERC in its 278th Meeting held on $16^{th} - 18^{th}$ January, 2020 for noncompliance of SCN Issued previously on 18.05.2019 and committee took decision as under:

a) List of teaching faculty is not duly approved by the affiliating body as per Appendix-4 of NCTE, Regulations, 2014.

In view of the above, the Committee decided as under:

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.
