- 2. **AND WHEREAS**, the ERC in its 275<sup>th</sup> (Part-2) meeting held on 27<sup>th</sup> July, 2019 considered that 1<sup>st</sup> show cause notice u/s 17(1) issued on 21.02.2109, followed by final show cause notice dated 18.06.2019 and the institution is still deficient on the following grounds:-
  - (i) Supporting documents along with testimonials of Principal and faculties at sl. No.2, 3, 4, 9, 13, 14 & 15 appointed after 09.06.2017 as required under NCTE Regulations, 2014 not submitted.
  - (ii) No Mathematics lecturer appointed.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Kamala Devi Sohanraj Singhvi Jain College of Education, 6, Ram Gopal Ghosh Road, Cossipore, Dist.- Kolkata, West Bengal- 700002 (APE00737) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
