**ORDER**

WHEREAS, Kamala Devi Sohanraj Singhvi Jain College of Education, 6, Ram Gopal Ghosh Road, Cossipore, Dist.- Kolkata, West Bengal- 700002 (APE00737) was granted recognition for conducting B.Ed. course with an intake of 100 vide ERC order No.12717 dated 25.08.2008, followed by revised order vide No.32348 dated 29.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 275<sup>th</sup> (Part-2) meeting held on 27<sup>th</sup> July, 2019 considered that 1<sup>st</sup> show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 18.06.2019 and the institution is still deficient on the following grounds:-

- (i) Supporting documents along with testimonials of Principal and faculties at sl. No.2, 3, 4, 9, 13, 14 & 15 appointed after 09.06.2017 as required under NCTE Regulations, 2014 not submitted.
- (ii) No Mathematics lecturer appointed.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. **NOW THEREFORE**, recognition granted to the institution viz. Kamala Devi Sohanraj Singhvi Jain College of Education, 6, Ram Gopal Ghosh Road, Cossipore, Dist.- Kolkata, West Bengal- 700002 (APE00737) for B.Ed. Course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
