### **ORDER**

WHEREAS, Kamala Devi Sohanraj Singhvi Jain College of Education, 6, Ram Gopal Ghosh Road, Cossipore, Kolkata, West Bengal-700002 (APE00737) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC order dated 25.08.2008, followed by revised recognition order issued on 29.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHERAS**, the ERC in its 275<sup>th</sup> (part-2) meeting held on 27<sup>th</sup> July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61477 dated 02.09.2019 from the academic session 2020-2021 to the institution on the following grounds:
  - (i) Supporting documents along with testimonials of Principal and faculties at sl. No.2, 3, 4, 9, 13, 14 & 15 appointed after 09.06.2017 as required under NCTE Regulations, 2014 not submitted.
  - (ii) No Mathematics lecturer appointed.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 02.09.2019. The Appellate Authority vide order No.89-457/E-141847/2019 Appeal/2<sup>nd</sup> Mtg.-2020/30<sup>th</sup> January, 2020/89798 dated 02.03.2020 remanded back to the ERC with a direction to consider the approved staff list and other connected documents to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the approved staff list and other documents submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.
- 4. **AND WHEREAS**, the institution submitted representation vide letter dated 25/01/2020 received in this office on 30.01.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 02.03.2020, were carefully considered by ERC in its 282<sup>nd</sup> meeting held on 8<sup>th</sup> & 9<sup>th</sup> July, 2020 and the committee decided as under:-

"Restoration of Recognition Order of B.Ed. course to be issued".
