<u>ORDER</u>

WHEREAS, Sree Sree Ramakrishna B.Ed. College, Nischintapur, Ps – Kulpi, Dist – 24 Parganas (S), West Bengal – 743374. (APE00749) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2009-2010 vide ERC Order No. 3807 dated 29.04.2004, followed by revised order vide No.32257 dated 27.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 271^{st} meeting held on $24^{th} - 25^{th}$ April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 21.05.2019 to the institution on the following grounds:

- (i) The submitted faculty list comprises 11 instead of 16 as per NCTE Regulations, 2014.
- (ii) Building completion certificate is not in accordance with NCTE prescribed proforma.

3. AND WHEREAS, the ERC in its 278^{th} Meeting held on $16^{th} - 18^{th}$ January, 2020 considered the matter and reply dated 10.06.2019 from the institution in response to Show Cause Notice dated 21.05.2019 and observed as under.

Ist show cause notice u/s 17(1) issued on 21.02.2019 follow by Final show cause notice issued dated 21.05.2019 and the institution is still deficient on the following ground:-

(i) Building Completion Certificate (BCC) is not duly signed by the completent authority.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

4. NOW THEREFORE, recognition granted to the institution viz. Sree Sree Ramakrishna B.Ed. College, Nischintapur, Ps – Kulpi, Dist – 24 Parganas (S), West Bengal – 743374 (Code No. APE00749) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
