ORDER

WHEREAS, Deben Mahato Teacher Training Institute, At.- Paharigora, P.O.- Deoli, P.S.- Santaldih, Dist.- Purulia, West Bengal- 723146 (APE00787) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC order No.102089 dated 24.02.2008, followed by revised order vide No.32035 dated 24.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered that 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following grounds:-

(i) FDR towards Endowment and Reserve Fund in single mode.

In view of the above, the Committee decided as under:

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. **NOW THEREFORE**, recognition granted to the institution viz. Deben Mahato Teacher Training Institute, At.- Paharigora, P.O.- Deoli, P.S.- Santaldih, Dist.- Purulia, West Bengal- 723146 (APE00787) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
