**ORDER**

**Change of Premises of the Institution**

**WHEREAS**, Bankura College of Education, At- Katjuridanga, P.O.- Kenduadihi, Bankura-Purulia Main Road, Dist.- Bankura, West Bengal- 722102 (Code No. APE00810) granted recognition for conducting B.Ed. course with an annual intake of 100 (Two Basic Units) vide order dated 06.08.2007, followed by revised order issued vide order No. 32384 dated 29.05.2015 as per NCTE Regulation, 2014.

2. **AND WHEREAS**, the aforesaid institution had submitted application dated 05.01.2018 and 15.05.2018 for shifting of premises along with requisite documents.

3. **AND WHEREAS**, the ERC in its 258<sup>th</sup> meeting held on 22<sup>nd</sup> – 23<sup>rd</sup> July, 2018 decided that VT be constituted for shifting of premises. Accordingly, the inspection of the institution at new premises was conducted on 28.10.2018 and Visiting Team Report received at ERC, NCTE on 31.10.2018.

4. **AND WHEREAS**, the ERC in its 263<sup>rd</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> November, 2018 after considering and examining the application along with the documents submitted by the institution, agenda note, NCTE Act, NCTE Regulations 2014 including Norms and Standards, guidelines received from NCTE Hqs. from time to time and VTR for shifting of premises, discussed the matter in detail and decided as under:

**"Shifting of the institution to its new premises i.e. Bankura College of Education, Plot No.- 143, At- Bikna, P.O.- Keshiakole, P.S.- Bankura, Dist.- Bankura, West Bengal- 722155 is permitted."**
