ORDER

WHEREAS, Renuka Debi B.Ed. College, PO – Shyamnagar, Betai –Plassey Road, Dist – Nadia, West Bengal – 741155 (APE00846) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC's Order No. 12815 dated 30.08.2008, followed by revised recognition order vide No. 31824 dated 22.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 267th Meeting held on 10th – 11th February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution.

3. AND WHEREAS, the institution has submitted reply dated 24.04.2019 in response to SCN, which was considered by ERC in its 274th Meeting held on 15th – 16th July, 2019 and Final Show Cause Notice u/s 17(1) was issued on 02.09.2019 to the institution on the following grounds:-


- (i) Affidavit submitted for maintaining website is not accepted.
- (ii) The institution is to maintain and update information on its website as per clause 7(14)(i) of NCTE Regulations, 2014.

4. AND WHEREAS, the institution has submitted reply dated 19.09.2019 received in this office on 23.09.2019. The ERC in its 279th Meeting held on 14th – 16th February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

- (i) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.




