3. **AND WHEREAS**, the institution has submitted reply dated 24.04.2019 in response to SCN, which was considered by ERC in its 274^{th} Meeting held on $15^{th} - 16^{th}$ July, 2019 and Final Show Cause Notice u/s 17(1) was issued on 02.09.2019 to the institution on the following grounds:-

- (i) Affidavit submitted for maintaining website is not accepted.
- (ii) The institution is to maintain and update information on its website as per clause 7(14)(i) of NCTE Regulations, 2014.

4. AND WHEREAS, the institution has submitted reply dated 19.09.2019 received in this office on 23.09.2019. The ERC in its 279^{th} Meeting held on $14^{th} - 16^{th}$ February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

(i) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.
