WHEREAS, Holy Child B.Ed. College, Vill - Noonbahi Road, Holy Child Campus, PO - Malda Head Post Office, Dist - Malda, West Bengal - 732 101 was granted recognition for conducting B.Ed. Course of one year duration with an annual intake of 100 (one hundred) students vide ERC order No.ERC/7-88.6(II).4/2008/12810 Dt.30.08.2008.

- 2. WHEREAS on the basis of complaint against the institution namely Holy Child B.Ed. College, Vill Noonbahi Road, Holy Child Campus, PO Malda Head Post Office, Dist Malda, West Bengal 732 101, the Eastern Regional Committee considered the matter in its 104th meeting held on 28 29 January 2010, and decided to inspect the institution before taking further action U/S 17 of the NCTE Act.
- 3. AND WHEREAS, the inspection of the institution U/S 17 was conducted on 31-May-2010.
- 4. AND WHEREAS, the VT report along with the original file was considered by the ERC in its 109th meeting of ERC held on 21st-23rd June, 2010 whereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-
 - (i) As per land possession certificate the land is processed by Dr. Debasish Sarkar who is Secretary of the institution.
 - (ii) List of teaching staff not submitted.
 - (iii) Facilities for Language Learning Lab are not mentioned in the VT report.
 - (iv) The institution has not submitted the Affidavit on Rs.10/- stamp paper regarding individual teaching staff along with Principal.
 - (v) Experience certificate of the Principal namely Shri Sadhan Kumar Thakur not submitted.
 - (vi) As per VTR the Society registered on 13.07.2009 and application received on 2007.
 - (vii) The VTR has provided only the detail of one FDR for each of EF & RF whereas the institution is recognized for D.Ed. & B.Ed. Course.
 - (viii) The area demarcated for 2 course not clearly given by the VT.
 - (ix) Teacher for Primary Education not appointed by the institution. Faculty list approved by the affiliating University not submitted.

- (x) 3 classrooms has been provided by the institution.
- (xi) The plot no. mentioned in the affidavit are not same as in the land document. Further, khesra No. mentioned in the affidavit are not therein the schedule of the land of the VTR and of the affidavit)
- 5. AND WHEREAS the ERC directed that an opportunity be given to the institution to make a written representation within 30 days from the date of issue of the letter before withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice under section 17 was issued to the institution on 05.07.2010.
- 6. AND WHEREAS the matter was again considered by the Eastern Committee in its 112th meeting held on 30 Sept. 01Oct. 2009 and having taken into consideration all the relevant facts of the case, it was decided to withdraw recognition for conducting B.Ed. course from next academic session i.e., 2011-2012 for certain points as per the withdrawal order No.5381 dt.26-Oct-2010.
- 7. AND WHEREAS the Correspondent, Holy Child B.Ed. College, Vill Noonbahi Road, Holy Child Campus, PO Malda Head Post Office, Dist Malda, West Bengal 732 101 (hereinafter referred to as the applicant), preferred an appeal dated 22-Nov-2010 to the National Council for Teacher Education, New Delhi (hereinafter referred to as the Council) under Section 18 of the NCTE Act, 1993 against the said Order.
- 4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit, VT report and after considering oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal and reverse the ERC's order dated 26-10-2010 with a direction to ERC for re-examination of the reply submitted by the institution in response to the show cause notice taking into account the VT report and the documents submitted therewith, the complaint dated 08-06-2010 and the documents received along with it and take appropriate decision No.F.No.-89-1073/2010 thereafter, vide Hars. Order Appeal/A35765 dated 26-Apr-2011.
- 5. AND WHEREAS the matter was again considered by the Eastern Committee in its 120th meeting held on 24th-25th June 2011 considered original file of the institution in pursuance of directions of the Appellate Authority vide Order No.F.No.-89-1073/2010 Appeal/A35765 dated 26-Apr-2011 and decided to issue Notice Under Section 17(1) to the institution and as per the decision of the Committee Notice U/S 17(1) was issued vide No.8193 Dt.11-Aug-2011

AND WHEREAS a the matter was again considered by the Eastern Committee in its 134th meeting held on 23th-24th May 2011 considered original file of the institution, directions of the Appellate Authority vide Order No.F.No.-89-1073/2010 Appeal/A35765 dated 26-Apr-2011 and reply submitted by the institution dt.09-Sep-2011 received on 13-Sep-2011 and other related documents submitted by the institution was considered and the Eastern Regional Committee decided as under:

"After considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE HQr and the reply of the institution dated 7 Feb 2012, the Committee discussed the matter in detail and observed as under:

A clarification letter dated 17 Dec 2011was sent to the District Mass education Extension Officer, Malda (WB) requesting to confirm the genuineness of the certificate dated 9 Sep 2011 issued by them regarding the fact that no other institution is functioning inside the campus of Holy Child B.Ed. College. The institution submitted its reply with the certificate from Office of the District Inspector of Schools (Secondary Education) Malda WB to this effect. The committee was satisfied with the content of the certificate.

In view of the above the Committee decided as under:

Recognition of the institution for the B.Ed course be restored from the session 2012-13."

5. NOW, THEREFORE, as per the above decision of the 134th ERC held on 23rd-24th May 2012 the Eastern Regional Committee hereby restores the Recognition withdrawn vide Order No.ERC/7-112.53.24./2010/5381 Dt.26-Oct-2010 on the same terms and conditions as contained in the Recognition Order No. ERC/7-88.6(II).4/2008/12810 dated 30.08.2008 to the institution viz. Holy Child B.Ed. College, Vill – Noonbahi Road, Holy Child Campus, PO – Malda Head Post Office, Dist – Malda, West Bengal – 732 101 from the Session 2012-13.
