#### <u>ORDER</u>

WHEREAS, Vidyasagar Foundation School of Education & Training, Vill.- Tamna, P.O.- Simulia, Dist.- Purulia, West Bengal- 723102 (APE00876) was granted recognition for conducting B.Ed. course with an intake of 100 vide ERC order No.12806 dated 30.08.2008, followed by revised order vide No.32328 dated 28.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 275<sup>th</sup> (Part-1) meeting held on 26<sup>th</sup> July, 2019 considered that 1<sup>st</sup> show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 20.05.2019. The institution is still deficient on the following grounds:-

(i) Building plan approved by Govt. Engineer is not submitted.

(ii) The validity of FDRs expired on 16.06.2019.

(iii) Faculty list is not submitted.

(iv) Website not updated.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Vidyasagar Foundation School of Education & Training, Vill.- Tamna, P.O.- Simulia, Dist.- Purulia, West Bengal- 723102 (APE00876) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
