WHEREAS, Gour Malda College of Education, Vill.- Kamalpur, Kamalbari, P.O.- Meherapur, Dist.- Malda, West Bengal- 732207 (Code No. APE00889) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2009-2010 vide ERC order dated 15.01.2010, followed by revised order dated 23.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 275th (Part-2) meeting held on 27th July, 2019 considered the matter and observed that 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 19.06.2019 and the institution is still deficient on the following ground:-
 - (i) The submitted faculty comprises of 1+14 instead of 1+15 required under NCTE Regulations, 2014. Hence, faculties are insufficient to run 100 intake of B.Ed. course.
 - (ii) * No reply of SCN received and the stipulated time period has already been over.

The intake for B.Ed. course be reduced from 100 to 50 from the academic session 2020-2021 with intimation to the institution and all concerned.

3. NOW THEREFORE, recognition granted to the institution viz. Gour Malda College of Education, Vill.- Kamalpur, Kamalbari, P.O.- Meherapur, Dist.- Malda, West Bengal-732207 (Code No. APE00889) for conducting B.Ed. Course is hereby reduced intake from 100 to 50 (One basic unit) from the academic session 2020-2021.
