#### **ORDER**

WHEREAS, Nandanpur Teacher's Training Institute, Vill.- Nandanpur, P.O.- Sekendari, Dist.- Midanapore, West Bengal- 721146 (APE00897) was granted recognition for conducting B.Ed. course with an intake of 100 vide ERC order No.2887 dated 08.01.2010, followed by revised order vide No.32049 dated 24.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its  $274^{th}$  meeting held on  $15^{th}$   $16^{th}$  July, 2019 considered that  $1^{st}$  show cause notice u/s 17(1) issued on 05.11.2018. Final show cause notice issued dated 12.03.2019 and the institution is still deficient on the following grounds:-
  - (i) Faculty list is not approved by concerned affiliating body.
  - (ii) Selection/appointment of principal is not made as per prescribed procedure

In view of the above, the Committee decided as under:

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Nandanpur Teacher's Training Institute, Vill.- Nandanpur, P.O.- Sekendari, Dist.- Midanapore, West Bengal-721146 (APE00897) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
