ORDER

WHEREAS, Nandanpur Teacher's Training Institute, Vill.- Nandanpur, P.o.- Sekendari, Dist.- Midanapore, West Bengal – 721146 (APE00897) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2009-2010 vide ERC dated 08.01.2010, followed by revised recognition order issued on 24.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. AND WHEREAS, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered the matter and as decided, recognition to B.Ed. course was withdrawn u/s 17(1) vide order no. 61322 dated 22.08.2019 from the academic session 2020-2021 to the institution.


3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 22.08.2019. The Appellate Authority vide order No.89-359/E-135588/2019 Appeal/33rd Mtg.-2019/21st November, 2019/85818 dated 05/12/2019 remanded back to the ERC with a direction to consider the approved faculty list, including the principal, to be sent to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC, the approved faculty list, with originals, wherever necessary, within 15 days of receipt of orders on the appeal.

4. AND WHEREAS, the ERC in its 279th meeting held on 14th – 16th February, 2020 after considering the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 05.12.2019 as well as reply dated 19.12.2019 submitted by the institution and the following observation was made:

“Restoration of recognition order of B.Ed. course to be issued”.

5. NOW, THEREFORE, recognition withdrawn vide order dated 22.08.2019 to the institution viz. Nandanpur Teacher's Training Institute, Vill.- Nandanpur, P.o.- Sekendari, Dist.- Midanapore, West Bengal – 721146 (Code No. APE00897) for B.Ed. course is hereby restored.


