**ORDER**

WHEREAS, Ehiapur B.Ed. College, Vill. & P.O.- Ehiapur, P.S.- Ketugram, Dist- Burdwan, West Bengal - 713129. (Code No. APE00901) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 878 dated 28.07.2009, followed by revised order vide No.32180 dated 26.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, Recognition of B.Ed. Course (100 intakes) is withdrawn vide Order No. 60492 dated 20.05.2019 as per the decision of 270<sup>th</sup> ERC meeting held on 25<sup>th</sup> - 26<sup>th</sup> March, 2019 on the following grounds:-

- Validity of earlier submitted FDRs issued by Allahabad Bank expired on 25.04.2018. The institution is required to submit FDRs of Rs. 5 lakh & Rs. 7 lakh towards EF & RF in joint operation mode as per NCTE Regulations, 2014.

3. AND WHEREAS, the institution has preferred an appeal Order No. F.No.89-311/E-128235/2019 Appeal/28<sup>th</sup> Mtg.-2019/28<sup>th</sup> August, 2019 against the ERC withdrawn order dated 20.05.2019 and placed on ERC's 277<sup>th</sup> meeting held on 19<sup>th</sup> - 20<sup>th</sup> Dec, 2019 consider the matter and as decided, Show Cause Notice u/s 17 was issued on 26.12.2019 to the institution on the following grounds:

- List of Principal and 15 faculty members duly approved by the affiliating body in original need to be submitted.

4. AND WHEREAS, the ERC in its 278<sup>th</sup> Meeting held on 16<sup>th</sup> - 18<sup>th</sup> January, 2020 considered the matter along with the reply received on 06.01.2020 submitted by the institution in response to Show Cause Notice and observed as under:

> Restoration of recognition order of B.Ed. Course to be issued.


