**ORDER**

WHEREAS, Vidya Sagar Teacher's Training College, Vill.- Barasagardighi, P.O.- Kamalbari, Town/City- Malda, Dist.- Malda, West Bengal- 732103 (APE00977) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2010-2011 vide ERC Order No.5078 dated 22.09.2010, followed by revised order vide No.32485 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC,

2. **AND WHEREAS**, the ERC in its 269<sup>th</sup> (Part-II) meeting held on 02<sup>nd</sup> - 03<sup>rd</sup> March, 2019 considered the reply dated 27.10.2015 in response to revised recognition order submitted by the institution along with letter dated 04.04.2017 from University of Gour Banga, West Bengal and observed as under:

- (i) The college has been de-affiliated by University of Gour Banga, Malda, West Bengal, as intimated vide letter Ref. No.210/UGB/CE-17 dated 04.04.2017 by Controller of Examination (Addl. Charge) of the concerned University.

**In view of the above, the Committee decided as under:**

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. APE00977 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.

3. **NOW THEREFORE**, recognition granted to the institution viz. Vidya Sagar Teacher's Training College, Vill.- Barasagardighi, P.O.- Kamalbari, Town/City- Malda, Dist.- Malda, West Bengal- 732103 (APE00977) for B.Ed. Course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.

4. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of the issue of the order.


