#### **ORDER**

#### Change of premises of the institution

Mahula Sri Ramkrishnan Teacher's Training Institute, Vill.- Kanachi, P.O. – Kanachi, Tehsil - Rampurhat, Dist. – Birbhum, West Bengal (Code No. APE01132) granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2009-2010 vide ERC order No. ERC/7-98.5(i).3/2009/879 dt. 28.07.2009 as per decision taken in the 98<sup>th</sup> ERC meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2009 and subsequent Order vide No. ERC/NCTE/APE01132/ B.Ed.(Revised order)/2015/32256 dt. 27.05.2015 issued as per NCTE Regulation, 2014.

The aforesaid institution had submitted application dated 28.10.2015 for shifting of premises along with requisite documents received in ERC NCTE on 02.11.2015.

The ERC in its 228<sup>th</sup> meeting decided that VT to be constituted for shifting of premises. Accordingly, the inspection of the institution at new premises was conducted on 15.02.2017 and VT report received at ERC, NCTE on 20.02.2017.

The ERC in its 236<sup>th</sup> meeting was held on 25<sup>th</sup> – 28<sup>th</sup> March 2017, after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs. from time to time and VTR, the Committee discussed the matter in detail and decided as under:

"Shifting of the institution is permitted from old premises to new premises".

In view of the above, the institution is hereby permitted shifting of premises of the institution from "Mahula Sri Ramkrishnan Teacher's Training Institute, Vill.- Kanachi, Po.- Kanachi, Tehsil- Rampurhat, Dist.- Birbhum, West Bengal" to "Mahula Sri Ramkrishan Teachers Training Institute, Vill - Malanchi, Po.- Kanchi, Tehsil- Rampurhat, Dist. - Birbhum, West Bengal - 731216".
