WHEREAS, Krishnapur Teachers training Institute, Vill.- Krishnapur, P.O.-Krishnapur, Dist.- Birbhum, West Bengal- 731237 (APE001189) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2001-2002 vide ERC order No.24148 dated 21.02.2014, followed by revised order vide dated 24.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 274th meeting held on $15^{th} 16^{th}$ July, 2019 considered that 1^{st} show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 18.05.2019. The institution is still deficient on the following grounds:-
 - (i) The submitted FDRs are partially hand-written and partially typed without any bank authorization letter.
 - (ii) Nine faculities appointed after 09.06.2017 (Gazette Notification No.237 of NCTE) do not possess NET/Ph.D. qualification.

In view of the above, the Committee decided as under:

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Krishnapur Teachers training Institute, Vill.- Krishnapur, P.O.- Krishnapur, Dist.- Birbhum, West Bengal- 731237 (APE001189) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
