NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants permission to Bengal College Of Teacher Education, Plot No-421 & 423, Vill-Dhurabila, Tehsil/Taluka/Town/City-Chandrakona Town, P.O-Dhamkuria, Dist-Midnapore, West Bengal-721201 for conducting B.Ed.
