ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Hadechha Lachhimuddin B. Ed. - 3. AND WHEREAS the applicant institution/trust/society filed a writ petition (C) No. 362/13 in the Hon'ble Supreme Court of India against the said recognition order dated 30-May-13 issued by ERC, NCTE and the Hon'ble Supreme Court disposed of the writ petition with a direction that recognition granted by the NCTE to the institution will apply for the academic session 2013-2014.
- 4. AND WHEREAS the Eastern Regional Committee in its 158 Meeting held on 23-24 July 2013 considered the original file of the institution along with the order of the Hon'ble Supreme Court dated 26-06-2013 and decided that revised recognition order from the session 2013-2014 may be issued to the institution instead of the session 2014-2015.

- 6. The recognition is subject to fulfillment of the following:

- 7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
