ORDER

WHEREAS, Angel Teachers Training Academy, Plot No.- 373, 374, 375/888, Vill.- Rampur, P.O.- Rajput Teghori, Tehsil/Taluka- Raghunathganj, Town/City- Jangipur, Dist.- Murshidabad, West Bengal- 742213 (ERCAPP1045) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC order No.19475 dated 11.07.2013, followed by revised order vide No.32169 dated 26.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered that 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 18.05.2019 on the following grounds:-

- Approved faculty list by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

No reply received and the stipulated time period has already been over.

In view of the above, the Committee decided as under:

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. **NOW THEREFORE**, recognition granted to the institution viz. Angel Teachers Training Academy, Plot No.- 373, 374, 375/888, Vill.- Rampur, P.O.- Rajput Teghori, Tehsil/Taluka- Raghunathganj, Town/City- Jangipur, Dist.- Murshidabad, West Bengal- 742213 (ERCAPP1045) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.


