- 2. **AND WHEREAS**, the ERC in its 274^{th} meeting held on 15^{th} 16^{th} July, 2019 considered the matter and observed that 1^{st} show cause notice u/s 17(1) issued on 21.02.2019. The institution is deficient on the following ground:-
 - (i) Faculty list comprises 1+14 instead of 1+15 as per NCTE Regulations, 2014.

The intake for **B.Ed. course** be **reduced from 100 to 50** from the academic session **2020-2021** with intimation to the institution and all concerned.

Course is hereby reduced intake from 100 to 50 (One basic unit) from the academic session 2020-2021.
