#### <u>ORDER</u>

2. **AND WHEREAS**, the ERC in its 268<sup>th</sup> (Part-2) meeting held on 24<sup>th</sup> – 25<sup>th</sup> February, 2019 considered the matter in its meetings held time to time along with the reply dated 24.01.2019 submitted by the institution in response to Show Cause Notice and observed as under:

(i) Show Cause Notices were issued on 20.04.2018 and 14.12.2018.

- (ii) In response to last SCN, the institution failed to submit compliance regarding educational & professional qualification certificates in respect of appointed faculties at sl. No.2, 3, 10 & 11 of the faculty list and updation of its website.
- (iii) No more extension of time as sought by the institution is allowed by the Committee,

#### In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. ERCAPP1223 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.

3. NOW THEREFORE, recognition granted to the institution viz. Boinchee College of Education, Plot No.- LR337, Vill.- Boincheegram, P.O.- Boincheegram, Tehsil/Taluka-Pandua, Town/City- Boincheegram, Dist.- Hooghly, West Bengal- 712135 (ERCAPP1223) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.
