WHEREAS, East West Education Institute, Plot No.- 2780, Vill.- Talit, Tehsil/Taluka- Amar Mouza, Town/City- Bardhaman, P.O.- Talit, Dist.- Bardhaman, West Bengal- 713141 (Code No. ERCAPP1268) was granted recognition for B.Ed. course with an intake of 100 vide ERC Order No.19864 dated 31.07.2013, followed by revised order vide No.32272 dated 27.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its in its 272nd meeting reduced the intake capacity of B.Ed. course from 100 to 50 vide order No.60787 dated 18.06.2019 from the academic session 2019-2020 mentioning that the total built up area as per building completion certificate (B.C.C.) is 1739.94 Sq. Mts. In the meantime, the institution has submitted proper reply on the basis of proceedings uploaded on ERC website along with revised B.C.C. dated 26.03.2015 approved by Govt. Engineer mentioning that the total built up area is 2072 Sq. Mts. Hence, the institution has fulfilled the criteria for two basic units of 100 intake for B.Ed. as per NCTE Regulations, 2014.

3. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 analyzed the matter and decided as under:

Order reducing the intake from 100 to 50 issued to the institution is rectified by **restoring the recognition for 50 intake**, **thus making the total intake 100** from the academic session **2019-2020**. Accordingly, order be issued to the institution and all concerned.
