ORDER

WHEREAS, East West Model School Education Society, Plot No.- 2780, Vill.- Talit, Tehsil/Taluka- Amar Mouza, Town/City- Bardhaman, P.O.- Talit, Dist.- Bardhaman, West Bengal- 713141 (Code No. ERCAPP1268) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC order No.19864 dated 31.07.2013, followed by revised order vide No. 32272 dated 27.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 272nd meeting held on 30th - 31st May & 1st June, 2019 considered the matter along with the reply dated 09.04.2019 submitted by the institution in response to Show Cause Notice and observed as under:

(i) Show Cause Notice u/s 17(1) was issued on 28.03.2019.

(ii) Total built up area mentioned in the building completion certificate as 1739.94 Sq. Mts. (18728.71 Sq. ft.), which is less than required 2000 Sq. Mts. under NCTE Regulations, 2014 for running 02 units (100 intake) of B.Ed. course. Hence, the institution is entitled for intake of 50 (one unit) only.

In view of the above, the Committee decided as under:

The intake for **B.Ed. course** be **reduced from 100 to 50 from the academic session 2019-2020** with intimation to the institution and all concerned.

3. NOW THEREFORE, recognition granted to the institution viz. East West Model School Education Society, Plot No.- 2780, Vill.- Talit, Tehsil/Taluka- Amar Mouza, Town/City-Bardhaman, P.O.- Talit, Dist.- Bardhaman, West Bengal- 713141 (Code No. ERCAPP1268) for conducting B.Ed. Course is hereby reduced intake from 100 to 50 (One basic unit) from the academic session 2019-2020.
