ORDER

AND WHEREAS the applicant institution/trust/society filed a writ petition (C) No. 349/2013 in the Hon'ble Supreme Court of India against the said recognition order dated 14-Jun-13 issued by ERC, NCTE and the Hon'ble Supreme Court disposed of the writ petition with a direction that recognition granted by the NCTE to the institution will apply for the academic session 2013-2014.

AND WHEREAS the Eastern Regional Committee in its 158 Meeting held on 23-24 Jul-2013 considered the original file of the institution along with the order of the Hon'ble Supreme Court dated 6/28/2013 and decided that revised recognition order from the session 2013-2014 may be issued to the institution instead of the session 2014-2015.
