<u>ORDER</u>

WHEREAS, Bhimpur Mohanananda College of Education, Plot No.- RL 1151, 1169, 1170, 1171 Vill.- Bhimpur, P.O.- Bhimpur, Dist.- Nadia, West Bengal- 741167 (Code No. ERCAPP140) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC order dated 06.03.2012, followed by revised order dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 274th meeting held on $15^{th} - 16^{th}$ July, 2019 considered the matter and observed that 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 20.05.2019 and the institution is still deficient on the following grounds:-

(i) Faculty list comprises 1+12 instead of 1+15 as per NCTE Regulations, 2014.
(ii) Faculty at sl. no.10 & 13 of the list do not possess NET/Ph.D. qualification as per Gazette Notification dated 09.07.2017.

The intake for **B.Ed. course** be **reduced from 100 to 50** from the academic session **2020-2021** with intimation to the institution and all concerned.

3. NOW THEREFORE, recognition granted to the institution viz. Bhimpur Mohanananda College of Education, Plot No.- RL 1151, 1169, 1170, 1171 Vill.- Bhimpur, P.O.- Bhimpur, Dist.- Nadia, West Bengal- 741167 (Code No. ERCAPP140) for conducting B.Ed. Course is hereby reduced intake from 100 to 50 (One basic unit) from the academic session 2020-2021.
