ORDER

WHEREAS, Ananda Marga Gurukula Teachers Training College, Plot No.- 107,05,10, Street No.- 01, Vill.- Ananda Nagar, P.O.- Bagalata, Tehsil/Taluka- Purulia, Town/City- Ananda Nagar, Dist.- Purulia, West Bengal- 723215 (ERCAPP1414) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC order No.24427 dated 03.03.2014, followed by revised order vide No.32115 dated 26.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered that 1st show cause notice u/s 17(1) issued on 20.04.2018. Final show cause notice issued dated 14.06.2019 on the following grounds:-

- (i) Principal is not appointed.
- (ii) Faculty list comprises of 8 only instead of 1+15 required under NCTE Regulations, 2014. Out of 8, three faculties mentioned at sl. No.3, 4 & 8 of the approved list do not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.
- (iii) Total built up area not mentioned in the submitted building completion certificate.

No reply received and the stipulated time period has already been over.

In view of the above, the Committee decided as under:

Recognition granted to B.Ed. course is withdrawn under section-17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. **NOW THEREFORE**, recognition granted to the institution viz. Ananda Marga Gurukula Teachers Training College, Plot No.-107,05,10, Street No.- 01, Vill.- Ananda Nagar, P.O.- Bagalata, Tehsil/Taluka- Purulia, Town/City- Ananda Nagar, Dist.- Purulia, West Bengal- 723215 (ERCAPP1414) for B.Ed. Course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
