**ORDER**

WHEREAS, Ananda Marga Gurukula Teachers Training College, Plot No.-107, 05, 10, Street No.-01, Vill.-Ananda Nagar, P.O.- Bagalata, Tehsil/Taluka-Purulia, Town/City-Ananda Nagar, Dist.-Purulia, West Bengal-723215 (ERCAPP1414) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC order dated 03.03.2014, followed by revised recognition order issued on 26.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. AND WHEREAS, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61281 dated 20.08.2019 from the academic session 2020-2021 to the institution.


3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 20.08.2019. The Appellate Authority vide order No.89-418/E-139383/2019 Appeal/37<sup>th</sup> Mtg.-2019/27<sup>th</sup> November, 2019/86537 dated 23/12/2019 remanded back the case to ERC with a direction to consider the documents to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the documents submitted in the appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.

4. AND WHEREAS, the institution has submitted representation vide letter dated 08.01.2020 received in this office on 11.01.2020. The ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> – 16<sup>th</sup> February, 2020 considered the matter and as decided, Show Cause Notice was issued on 28.02.2020 to the institution on the following grounds:

- (i) Experience certificate of the Principal is not submitted.
- (ii) Built up area mentioned in the Building Plan (BP) and Building Completion Certificate does not match.

5. AND WHEREAS, the institution submitted reply vide letter dated 16/03/2020 received in this office on 08/05/2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 282<sup>nd</sup> meeting held on 8<sup>th</sup> & 9<sup>th</sup> July, 2020 and the committee decided as under:-

“Restoration of Recognition Order of B.Ed. course to be issued”.




