- 2. **AND WHEREAS**, the ERC in its 275th (Part-2) meeting held on 27th July, 2019 considered that 1st show cause notice u/s 17(1) issued on 14.02.2109, followed by final show cause notice dated 14.06.2019 and the institution is still deficient on the following ground:-
 - (i) Faculties at sl. No.3 & 13 appointed after 09.06.2017 for Pedagogy subjects do not have NET/Ph.D. qualification as per Gazetie Notification No.237 of NCTE published on 09.06.2017.

(ii) Faculty list is not approved by Registrar of the concerned affiliating body.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Joypur B.Ed. College, Plot No.- 1306/1363, 1306/1394, Vill.- Podumpur, P.O.- Joypur, Tehsil/Taluka- Jangal Mahal, Town/City- Bishnupur, Dist.- Bankura, West Bengal- 722138 (ERCAPP1656) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
