WHEREAS, Joypur B.Ed. College, Plot No.-1306-1363, 1306-1394, Vill.-Podumpur, P.O.-Joypur, Tehsil/Taluka-Jangal Mahal, Town/City-Bishnupur, Dist.-Bankura, West Bengal-722138 (ERCAPP1656) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC order dated 12.02.2014, followed by revised recognition order issued on 25.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHERAS,** the ERC in its 275th meeting held on 27th July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61490 dated 02.09.2019 from the academic session 2020-2021 to the institution.
- 3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC's order dated 02.09.2019. The Appellate Authority vide order No.89-349/E-134467/2019 Appeal/31st Mtg.-2019/15th October, 2019 dated 06.11.2019 remand back the case to the ERC with a direction to consider the latest consolidated approved faculty list, to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the latest consolidated approved faculty list, within 15 days of receipt of orders on the appeal.
- 4. **AND WHEREAS,** the institution has submitted reply vide letter dated 11.11.2019 received in this office on 20.11.2019. The ERC in its 277^{th} meeting held on $19^{th} 20^{th}$ December, 2019 considered the matter and as decided, Show Cause Notice was issued on 26.12.2019 to the institution on the following grounds:
 - (i) Original list of members of faculty duly approved by the affiliating University need to be submitted.
- 5. AND WHEREAS, the institution submitted reply vide letter dated 06.01.2020 received in this office on 10.01.2020. The ERC in its 280th meeting held on 29th February & 1st March, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under:-

"Restoration of recognition order of B.Ed. course to be issued".
