ORDER

WHEREAS, Siksha Bikash Seba Foundation B.Ed. College, Plot No.- 604, 628, Vill.- Nudipur More, P.O.- Chotkhanda, Tehsil/Taluka- Memari, Town/City- Burdwan, Dist.- Bardhaman, West Bengal- 713146 (ERCAPP1712) was granted recognition for conducting B.Ed. course with an intake of 100 vide ERC order No.20593 dated 31.08.2013, followed by revised order vide No.32141 dated 26.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 275th (Part-2) meeting held on 27th July, 2019 considered that 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 14.06.2019 and the institution is still deficient on the following grounds:-

- (i) Faculties at sl. No.3 & 5 appointed after 09.06.2017 for Pedagogy subjects do not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.
- (ii) Request of the institution for extension of time is not accepted.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. **NOW THEREFORE**, recognition granted to the institution viz. Siksha Bikash Seba Foundation B.Ed. College, Plot No.- 604, 628, Vill.- Nudipur More, P.O.- Chotkhanda, Tehsil/Taluka- Memari, Town/City- Burdwan, Dist.- Bardhaman, West Bengal- 713146 (ERCAPP1712) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.


