<u>ORDER</u>

WHEREAS, Siksha Bikash Seba Foundation B.Ed. College, Plot No.- 604, 628, Vill.- Nudipur More, P.O.- Chotkhanda, Tehsil/Taluka- Memari, Town/City- Burdwan, Dist.-Bardhaman, West Bengal- 713146 (Code No. ERCAPP1712) was granted recognition for B.Ed. course of one year duration with an annual intake of 100 vide ERC order dated 31.08.2013 from the academic session 2014-2015.

2. **AND WHEREAS**, Revised Recognition Order (RRO) was issued to the institution vide ERC order No.32141 dated 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

3. **AND WHEREAS**, the ERC in its 275th (Part-2) meeting held 27th July, 2019 considered the matter and as decided, recognition to B.Ed. Course was withdrawn u/s 17(1) vide order No. 61480 dated 02.09.2019 from the academic session 2020-2021 on the following grounds:-

- (i) Faculties at sl. No.3 & 5 appointed after 09.06.2017 for Pedagogy subjects do not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.
- *(ii) Request of the institution for extension of time is not accepted.*

4. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 02.09.2019. The Appellate Authority vide its Order No.89-422/E-139538/2019 Appeal/37th Mtg.-2019/27th November, 2019/86549 dated 23.12.2019 remanded back the case to ERC to consider the new list of faculty approved by the Registrar of the affiliating university on 21.08.2019 to be sent to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the new approved faculty list, in original, if necessary, within 15 days of receipt of orders on the appeal.

5. **AND WHEREAS**, the institution has failed to submit reply as per the direction of Appellate Authority within the stipulated time period of 15 days. The ERC in its 279^{th} meeting held on $14^{\text{th}} - 16^{\text{th}}$ February, 2020 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 28.02.2020 to the institution.

6. **AND WHEREAS**, the institution submitted reply vide letter dated 24.02.2020 received in ERC, NCTE on 28.02.2020. The ERC in its 280th Meeting held on 29th February 1st March, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and decided as under:-
