<u>ORDER</u>

WHEREAS, Banuali and Ajiran Teachers Training Institute, Vill.-Radhakrishnapur, PO.- Radhakrishnapur, Dist.- South 24 Parganas, West Bengal- 743373 (ERCAPP178) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC order dated 20.05.2012, followed by revised recognition order issued on 30.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. AND WHERAS, the ERC in its 272^{nd} meeting held on $30^{th} - 31^{st}$ May & 1^{st} June, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 60748 dated 14.06.2019 from the academic session 2020-2021 to the institution.

3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 14.06.2019. The Appellate Authority vide order No.89-325/E-130446/2019 Appeal/29th Mtg.-2019/11th October, 2019/83377 dated 25/10/2019 remanded back to the ERC with a direction to consider the new faculty list to be submitted to them by the appellant and take further action as per NCTE Regulations, 2014. The appellant is directed to forward to the ERC the latest faculty list submitted in appeal, with original thereof, within 15 days of receipt orders on the appeal.

4. AND WHEREAS, the institution has submitted reply vide letter dated 04.11.2019 received in this office on 05.11.2019. The ERC in its 277^{th} meeting held on $19^{\text{th}} - 20^{\text{th}}$ December, 2019 considered the matter and as decided, Show Cause Notice was issued on 26.12.2019 to the institution on the following grounds:

(i) Faculty mentioned at Sl. No. 10 (Mr. Jena) does not possess NET/Ph.D. qualification as per Gazette Notification dated 09.06.2017.

5. **AND WHEREAS**, the institution submitted reply vide letter dated 11.01.2020 received in this office on 13.01.2020. The ERC in its 280th meeting held on 29th February & 1st March, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under:-

"Restoration of recognition order of B.Ed. course to be issued".
