WHEREAS, Banuali and Ajiran Teachers Training Institute, Vill.- Radhakrishnapur, P.O.- Radhakrishnapur, Dist.- South 24 Parganas, West Bengal- 743373 (ERCAPP178) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC order No.11744 dated 20.05.2012, followed by revised order vide No.32489 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 272nd meeting held on 30th - 31st May & 1st June, 2019 considered the matter along with reply dated 26.03.2019 submitted by the institution in response to Show Cause Notice and observed as under:

- (i) 1st Show Cause Notice u/s 17(1) was issued on 18.01.2019.
 (ii) 2nd Show Cause Nation issued on 25 second on 18.01.2019.
- (ii) 2nd Show Cause Notice issued on 05.03.2019 allowing extension of 21 days time for compliance.
 (iii) Faculties mentioned at sl. No. 9, 8, 10, 45, 11
- (iii) Faculties mentioned at sl. No. 9 & 10 of the approved list have been appointed after 09.06.2017 who do not possess requisite NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.
- (iv) As per list, one more faculty falls short as per requirement (1+15) of NCTE Regulations, 2014.
 (v) The institution has requested wide by the second secon
- (v) The institution has requested vide letter dated 26.03.2019 seeking further extension of time for compliance.
 (vi) The Committee has not accepted the second date of the second second
- (vi) The Committee has not accepted the request of the institution.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. ERCAPP178 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Banuali and Ajiran Teachers Training Institute, Vill.- Radhakrishnapur, P.O.- Radhakrishnapur, Dist.- South 24 Parganas, West Bengal- 743373 (ERCAPP178) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
