## **ORDER**

WHEREAS, Adarshabani Teachers Training College, Plot No. – 568-720, Vill – Bagsarai, P.O. – Bagsarai, Dist. – Malda, West Bengal – 732124 (ERCAPP187) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC order dated 24.12.2012, followed by revised recognition order issued on 24.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHERAS,** the ERC in its 272<sup>nd</sup> meeting held on 30<sup>th</sup> 31<sup>st</sup> May & 1<sup>st</sup> June, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 60700 dated 14.06.2019 from the academic session 2020-2021 to the institution.
- 3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC's order dated 14.06.2019. The Appellate Authority vide order No.89-307/E-128029/2019 Appeal/27<sup>th</sup> Mtg.-2019/27<sup>th</sup> August, 2019/82354 dated 26.09.2019 remanded back to ERC for revisiting the case after the appellant submits the revised list containing the names of Principal and faculty.
- 4. **AND WHEREAS**, the ERC in its  $277^{th}$  meeting held on  $19^{th} 20^{th}$  December, 2019 considered the matter and as decided, Show Cause Notice was issued on 26.12.2019 to the institution on the following grounds:
  - (i) Faculty list of Foundation/ Perspective discipline as per clause 5.2 B. of Appendix-4 of the NCTE Regulations, 2014 is not appointed and academic credentials of teaching faculty credentials of teaching faculty including approved staff profile to be submitted.
  - (ii) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulations, 2014.
- 5. **AND WHEREAS**, the institution submitted reply vide letter dated 04.01.2020 received in this office on 07.01.2020. The ERC in its 280<sup>th</sup> meeting held on 29<sup>th</sup> February & 1<sup>st</sup> March, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under:-

"Restoration of recognition order of B.Ed. course to be issued".
