ORDER

WHEREAS, Adarshabani Teachers Training College, Plot No.- 568/720, Vill.- Bagsarai, P.O.- Bagsarai, Dist.- Malda, West Bengal- 732 124 (ERCAPP187) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC order No.15405 dated 24.12.2012, followed by revised order vide No.32050 dated 24.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 272nd meeting held on 30th 31st May & 1st June, 2019 considered the matter along with reply vide letters dated 07.03.2019, 08.04.2019 & 12.04.2019 submitted by the institution in response to Show Cause Notice and observed as under:
 - (i) Show Cause Notice u/s 17(1) were issued on 08.02.2019 & 21.02.2019.
 - (ii) Faculties viz. Moumita Chakraborty and Bhaskar Hore mentioned at sl. No.11 and 12 of approved list have been appointed after 09.06.2017 and do not possess requisite NET/Ph.D. qualification as per Gazettee Notification No.237 of NCTE published on 09.06.2017.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. ERCAPP187 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

- 3. NOW THEREFORE, recognition granted to the institution viz. Adarshabani Teachers Training College, Plot No.- 568/720, Vill.- Bagsarai, P.O.- Bagsarai, Dist.- Malda, West Bengal- 732 124 (ERCAPP187) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
- 4. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
