### **ORDER**

WHEREAS, Dr. Sarvepalli Radha Krishnan Teachers Training College, Plot No. LR-45, Vill – Doulatabad, Po – Doulatabad, Town/City- Berhampore, Dist – Murshidabad, West Bengal-742302 (ERCAPP223) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC order dated 21.05.2012, followed by revised recognition order issued on 27.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHERAS**, the ERC in its  $275^{\text{th}}$  (part-2) meeting held on  $27^{\text{th}}$  July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61485 dated 02.09.2019 from the academic session 2020-2021 to the institution on the following grounds:-

- (i) Faculty comprises 1+7 instead of 1+15 as per NCTE Regulations, 2014 for running 100 intake of B.Ed. course. Hence, faculty inadequate or insufficient.
- (ii) Five part-time faculties appointed are not accepted.
- (iii) Submitted building completion certificate is not in proper order without bearing date.
- (iv) Submitted building plan is not in proper order without bearing date.

3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC's order dated 02.09.2019. The Appellate Authority vide order No.89-451/E-141161/2019 Appeal/2<sup>nd</sup> Mtg.-2020/30<sup>th</sup> January, 2019/89774 dated 02.03.2020 remanded back to ERC with a direction to consider the documents to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the documents submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.

4. **AND WHEREAS,** the institution submitted reply vide letter dated 02.07.2020 received in this office on 07.07.2020. The ERC in its  $282^{nd}$  meeting held on 8<sup>th</sup> & 9<sup>th</sup> July, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under:-

"Restoration of Recognition Order of B.Ed. course to be issued".
