#### **ORDER**

WHEREAS, Indira Gandhi Teachers Training Institute, Vill.- Nowda, P.O.- Nowda, Town/City- Berhampur, Dist.- Murshidabad, West Bengal- 742183 (ERCAPP273) was granted recognition for conducting B.Ed. course of two years duration with an intake of 100 from the academic session 2012-2013 vide ERC Order No. 10150 dated 30.01.2012, followed by revised order vide No. 32459 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 268<sup>th</sup> (Part-2) meeting held on 24<sup>th</sup> 25<sup>th</sup> February, 2019 considered the matter in its meetings held time to time along with the reply dated 09.01.2019 submitted by the institution in response to Show Cause Notice and observed as under:
  - (i) Show Cause Notices were issued on 05.11.2018 and 15.12.2018.
  - (ii) Faculty list is not in the NCTE prescribed proforma and not duly approved by the concerned affiliating body.
  - (iii) Building completion certificate is not in the NCTE prescribed proforma.
  - (iv) Photocopy of FDRs are not in joint operation mode.

#### In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. ERCAPP273 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.

3. NOW THEREFORE, recognition granted to the institution viz. Indira Gandhi Teachers Training Institute, Vill.- Nowda, P.O.- Nowda, Town/City- Berhampur, Dist.- Murshidabad, West Bengal- 742183 (ERCAPP273) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.
