WHEREAS, Bangiyo Gurukul Ashram, Plot No.- 182, 183, 184, 185, 222, 223, Vill.- Bamihati, P.O.- Jasur Banipur, Tehsil/Taluka- Bamihati, Town/City- Habra, Dist.-North 24 Parganas, West Bengal- 743233 (Code No. ERCAPP3258) granted recognition for conducting B.Ed. course with an intake of 100 vide ERC order dated 02.05.2017 from the academic session 2017-2018.

- 2. **AND WHEREAS**, on the basis of inquiry report dated 08.05.2018 of Prof. Mita Banerjee, Former Vice-Chancellor of The West Bengal University of Teachers' Training, Education Planning and Administration, Kolkata, West Bengal, recognition withdrawn from the academic session 2017-2018 vide order dated 13.06.2018.
- 3. **AND WHEREAS**, the aforesaid institution had submitted application dated 17.05.2019 for shifting of premises along with requisite documents. Matter remanded back through Appeal Committee dated 10.04.2019 by which the ERC in its 272nd meeting held on 30th 31st May & 1st June, 2019 decided that VT be constituted for shifting of premises. Accordingly, the inspection of the institution at new premises was conducted on 29.06.2019 and Visiting Team Report received at ERC, NCTE on 08.07.2019.
- 4. **AND WHEREAS**, the ERC in its 274th meeting held on 15th 16th July, 2019 considered the visiting team report for shifting of premises with the observations of the VT members and decided as under:

"Restoration of recognition to B.Ed. course with 100 intake is accepted from the academic session 2019-2020 along with Shifting of the institution to its new premises i.e. Bangiyo Gurukul Ashram, Plot No.- 311, 312, 314, 315, 316, Vill.-Chaturia, P.O.- Noapara, P.S.- Duttapukur, Town/City- Barasat, Dist.- North 24 Parganas, West Bengal-700125 is permitted."
