NOW THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act. 1993, NCTE hereby grants recognition to Talandu M R and N C Mohanta College, Plot No.1965, 2031, Vill - Kushpukur, P.O. - Talandu, Tehsil/ Taluka - Polba, Town/ City - Chinsurah, Dist - Hooghly, West Bengal - 712148 for conducting B.Ed. programme of two years duration with an annual intake of 50 (One basic unit) from the academic session 2020-2021 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
