- 3.   - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
  - The institution shall comply with the various other norms and standards prescribed in the NCIE regulations, as amended from time to time.
  - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.

- IV. The institution shall ensure that the required number of academic staff duly approved by offiliating body for conducting the course should always remain in position.
- 4. The recognition/permission is subject to the condition that the institution shall move gradually to become a composite institution but not later than 2016-2017.
- 5. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc., as applicable.
- The institution shall submit to the Regional Committee a Self-Approisal Report
  at the end of each ocademic year along with the statement of annual accounts
  duly audited by a Chartered Accountant.
- 7. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned.   - i) The affidavil with enclosure submitted along with application:
  - The institution shall be free to post additional relevant information, If it so desires,
