ORDER

WHEREAS, Basirhat Maha Bodhi College of Education, Plot No. 692, 693, 694, 697, 698 & 699, Vill.- Arjunpur, PO.-Champapukur, Tehsil/Taluka-Basirhat, Dist.-North 24 Paraganas, West Bengal-743291 (Code No.ERCAPP39) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC Order No.11614 dated 17.05.2012, followed by revised order vide No.32085 dated 25.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

AND WHEREAS, the ERC in its 268th meeting held on 24th - 25th February, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 12.03.2019 to the institution on the following grounds:

- Consolidated faculty list comprising 1+15 as per NCTE Regulations, 2014 needs (i) to be submitted.
- FDRs in joint mode are not submitted. (iii)
- Fire safety certificate issued from the competent Govt. Authority not (iii) submitted.
- Submitted building completion certificate is not approved by Govt. Engineer. (iv)
- Website not maintained and updated. (\vee)

AND WHEREAS, the ERC in its 270th Meeting held on 25th - 26th March, 2019 considered the matter along with the reply dated 11.03.2019 (on the basis of proceedings uploaded on ERC website) submitted by the institution in response to Show Cause Notice and observed as under:

(i) Show Cause Notice u/s 17(1) was issued on 12.03.2019.

- (ii) Validity of photocopy FDRs Rs.5 lakh and Rs.3 lakh in joint mode expired on 17.10.2016 but not renewed.
- (iii) Fire safety certificate issued from the competent Govt. Authority not submitted.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No.ERCAPP39 is withdrawn under section 17(1) of NCTE Act,

1993 with effect from the academic session 2019-2020.
