**ORDER**

WHEREAS, Netaji Subas Chandra Bose Teachers Training College, Plot No. 88, 88-3028, Vill-Ratanpur, Tehsil/Taluka-Raiganj, Town/City-Bindole, P.O. - Bindole, Dist. - Uttar Dinajpur, West Bengal-733156 (ERCAPP459) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC order dated 31.08.2012, followed by revised recognition order issued on 30.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. AND WHEREAS, the ERC in its 272<sup>nd</sup> meeting held on 30<sup>th</sup> – 31<sup>st</sup> May & 1<sup>st</sup> June, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 60717 dated 14.06.2019 from the academic session 2020-2021 to the institution.


3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 14.06.2019. The Appellate Authority vide order No.89-322/E-130181/2019 Appeal/29<sup>th</sup> Mtg.-2019/11<sup>th</sup> October, 2019/83365 dated 25/10/2019 remanded back to the ERC with a direction to consider the documents submitted in appeal to be sent to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the documents in reference to the grounds of withdrawal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.

4. AND WHEREAS, the institution has submitted reply vide letter dated 04.11.2019 received in this office on 07.11.2019. The ERC in its 277<sup>th</sup> meeting held on 19<sup>th</sup> – 20<sup>th</sup> December, 2019 considered the matter and as decided, Show Cause Notice was issued on 26.12.2019 to the institution on the following grounds:

- (i) No faculty list of Foundation/ Perspective appointed as per clause 5.2 B. of Appendix-4 of the NCTE Regulations, 2014 submitted.
- (ii) FDRs in original along with Form 'A' need to be submitted.
- (iii) Member of teaching faculty list has not been updated in the institutional website as prescribed under 7(14)(i) of NCTE Regulations, 2014.

5. AND WHEREAS, the institution submitted reply vide letter dated 03.01.2020 received in this office on 06.01.2020. The ERC in its 280<sup>th</sup> meeting held on 29<sup>th</sup> February & 1<sup>st</sup> March, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under:-

**“Restoration of recognition order of B.Ed. course to be issued”.**




