ORDER

WHEREAS, Netaji Subas Chandra Bose Teachers Training College, Plot No.- 88, 88/3028, Vill.- Ratanpur, Tehsil/Taluka- Raiganj, Town/City- Bindole, P.O.- Bindole, Dist.- Uttar Dinajpur, West Bengal- 733156 (ERCAPP459) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC order No.13895 dated 31.08.2012, followed by revised order vide No.32424 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 272nd meeting held on 30th - 31st May & 1st June, 2019 considered the matter along with reply vide letters dated 09.05.2019 (on the basis of proceedings uploaded on ERC website) submitted by the institution in response to Show Cause Notice and observed as under:

- (i) Show Cause Notice u/s 17(1) were issued on 21.02.2019 & 23.05.2019.
- (ii) Principal is not appointed.
- (iii) Authorization letter from the concerned bank with regard to conversion of FDRs into joint mode not submitted.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. ERCAPP459 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. **NOW THEREFORE**, recognition granted to the institution viz. Netaji Subas Chandra Bose Teachers Training College, Plot No.- 88, 88/3028, Vill.- Ratanpur, Tehsil/Taluka- Raiganj, Town/City- Bindole, P.O.- Bindole, Dist.- Uttar Dinajpur, West Bengal- 733156 (ERCAPP459) for B.Ed. Course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.




