WHEREAS, Shyamangini Kundu College of Education, P lot NO.- 12265, 12266, Street No.- Kagram Sal, Vill- Salar, P.O.- Salar, Tehsil/Taluka- Salar, Town/City- Salar, Dist-Murshidabad, West Bengal - 742401 (ERCAPP550) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC Order No. 13881 dated 31.08.2012, followed by revised order vide No.32098 dated 25.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional-infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its  $265^{th}$  meeting held on  $08^{th} - 09^{th}$  January, 2019, considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 22.01.2019 to the institution on the following grounds:

(i) After expiry of validity on 24.09.2015 of FDRs of Rs. 5 lakh and Rs. 3 lakh submitted earlier, the same are not renewed till date. Hence, the institution is required to submit FDRs of Rs. 5 lakh and Rs. 7 lakh towards EF & RF in joint operation mode as per NCTE Regulations, 2014

3. AND WHEREAS, the ERC in its  $278^{th}$  Meeting held on  $16^{th} - 18^{th}$  January, 2020 considered the matter along with the reply dated 11.02.2019 submitted by the institution in response to Show Cause Notice and observed as under:

a) FDR of Rs. 5 lakh & Rs. 7 lakh has not submitted as per NCTE Regulation, 2014.

# In view of the above, the Committee decided as under:

Hence, B.Ed. Course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.
