<u>ORDER</u>

WHEREAS, Srijoni College of Education, Vill.-Dakshin Chandipur, Po- Kota, PS-Dubrajpur, Dist.-Birbhum, West Bengal-731124 (ERCAPP65/2012) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 24361 dated 03/03/2014, followed by revised order vide No.32513 dated 30.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS,** the ERC in its 275th meeting held on 27th July, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 11/09/2019 to the institution on the following grounds:

- (i) Faculty in Bengali at sl. No.7 appointed after 09.06.2017 for Pedagogy subject does not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.
- (ii) The validity of FDRs in single mode expired on 20.02.2019 need to be renewed in joint mode along with authorization letter from bank.
- 3. AND WHEREAS, the ERC in its 279th Meeting held on 14th -16th February, 2020. considered the matter and reply received on dated 03/09/2019 from the institution (on the basis of minutes uploaded in the website) in response to Show Cause Notice dated 11/09/2019 and observed as under.

> 1^{st} show cause notice u/s 17(1) issued on 25/01/2019 follow by Final show cause notice issued dated 11/09/2019 and the institution is still deficient on the following ground:-

- (i) Original FDRs Rs.5 lakh and Rs.3 lakh have been expired. Institution has not submitted original renewed FDRs of Rs.5 lakh and Rs.7 lakh as per NCTE Regulation, 2014.
- (ii) Latest copy of Fire Safety Certificate duly signed by the Govt. competent Authority has not been submitted.
- (iii) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

4. NOW THEREFORE, recognition granted to the institution viz. Srijoni College of Education, Vill.-Dakshin Chandipur, Po- Kota, PS- Dubrajpur, Dist.-Birbhum, West Bengal-731124 (Code No. ERCAPP65/2012) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
