**ORDER**

**Change of Premises of the Institution**

Revised recognition Order issued vide order no F.ERC/NCTE/ (ERCAPP65/2012)/ B.Ed(Revised Order) /2015/32513 dated 30.05.2015 for conducting B.Ed Course with an intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulation 2014.
