  - Approved faculty list (current) by the concerned affiliating body along with requisite documents.
  - (ii) Approved building plan by the concerned competent Govt. Engineer/ Authority.
  - (iii) Approved building completion certificate by the convened competent Govt. Engineer/ Authority.
  - (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
  - (v) Confirmation on website updates of the institutions with all details along with affidavit.
- AND WHEREAS, the ERC in its 271st Meeting held on 24th 25th April, 2019 considered the matter along with the reply received on 13.03,2019 in response to Show Cause Notice and as decided to issue the Final show cause notice u/s 17(1) on 21.05.2019 to the institution on the following grounds:-
  - (i) Total built up are in the building completion certificate mentioned as 1955 Sq. Mts. Which is less than as required under NCTE Regulations, 2014.
  - (ii) Faculty list comprising only 1+7 instead of 1+15 as per NCTE Regulations, 2014 for running 02 units (100 intake) of B.Ed. programme.
- AND WHEREAS, the ERC in its 278th Meeting held on 16th 18th January, 2020 considered the matter along with the reply received on 10.06.2019 submitted by the institution in response to Show Cause Notice and observed as under:
  - b) Original list of teaching faculty duly signed by the affiliating body as per NCTE Regulation, 2014 has not been submitted.

In view of the above, the Committee decided as under:

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next

academic session 2020-2021.
