- 2. **AND WHEREAS**, the ERC in its 275th (Part-2) meeting held on 27th July, 2019 considered that 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 17.06.2019 and the institution is still deficient on the following grounds:-
 - (i) Building plan is not legible.

(ii) Principal is not appointed.

(iii) Submitted faculty list is not in NCTE prescribed proforma.

(iii) Faculty comprises 09 instead of 1+16 as per NCTE Regulations, 2014 for running 100 intake of B.P.Ed. course.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Post Graduate Training College for Physical Education, Banipur, Dist.- North 24 Parganas, West Bengal- 743233 (APE00098) for B.P.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
